Hurricane Milton Allocation

Fast-Tracking Recovery for Residents

Following Hurricane Milton, Transform386 promptly initiated long-term recovery efforts. Upon confirmation of funding, the team prepared and submitted the Action Plan to HUD, which was approved twenty days ahead of schedule. The team worked as expeditiously as possible, to ensure timely access to assistance for residents. Prior to launch, an outreach event was held in Midtown Daytona to share information about the program and answer residents' questions. Within the first 30 days of the portal opening, over 130 applications were received, all currently under income eligibility review.

Program Snapshots

Infrastructure and Mitigation Progress

Twenty-two projects approved by the Volusia County Council bring together 7 municipalities, the County, and 3 nonprofit partners to strengthen community resilience. These projects harden wastewater treatment plants, expand stormwater retention, upgrade flood-prone lift stations, and improve major drainage systems, protecting homes and critical infrastructure.



Round 2 Infrastructure Application Under Review

20 additional infrastructure project applications have been received for funding from 10 agencies to mitigate future storm damages for the residents of Volusia County as well as preserve transitional housing shelters and historic assets of our county for future generations. The projects are anticipated of going to county council for approval in October.

Stormwater Studies Underway

Transform386 is fully funding 30 stormwater studies, helping cities and counties assess risks and plan future flood mitigation. Seven cities, including Daytona Beach, New Smyrna Beach, and South Daytona, are using these studies to shape master plans and Capital Improvement Programs. 12 are already in progress, and the rest are currently moving through the procurement process.

Multi-Family Housing Progress

Transform386 awarded 4 multifamily housing projects to replace housing lost in Volusia County due to Hurricane Ian, providing a total of **280** affordable units for individuals at or below 80% of the AMI:

- 1 project (80 units) has completed environmental review and is set to close on 08/26.
- 1 senior housing project (56 units) is in environmental review, with HUD approval expected in late September.
- 2 projects (60 units and 84 units) are in the agreement draft stage.
